<u>ASD-STAN information regarding the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016</u> on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as (GDPR)

# 1. Q: Who is responsible for any processing of personal data and how can I contact ASD-STAN in case of data breach?

A: All the requests must be addressed to ASD-STAN using the below details:

#### 2. Q: Which kind of data are used and stored?

A:

✓ If you are a customer:

We use and store the Data (as Name/Surname, Address, Company, Email address, etc.) which are necessary to perform your purchase request when creating an account at the ASD-STAN webshop. According to the Belgian Legislation, all the purchase related information as the invoice and customer details must be stored for 10 years. For purchase/free download of the ASD-STE 100 document, your data (Name, Address, Company, Email address, Position, Website, Country) will be forwarded to the ASD PSSG.

✓ If you are an Originator of a standard proposal, here are the details we use and store:

Your data (Name/Surname, Company, Email address, Phone No., Country)

✓ If you are an Expert of an ASD-STAN working group, or participant of the ASD-STAN bodies, here are the details we use, store and distribute within the committee:

Your data (Name, Company, Email address, Phone No., Country)

✓ If you are a recipient of the ASD-STAN Newsletter or information notes here are the details we use and store:



Your data (Name/Surname, Email address)

# Q: Why we are using and storing your data?A:

- to perform your purchase request-to be stored for 10 years according to the Belgian law;
- to send the requested information to a recipient of the ASD-STAN Newsletter or information notes;
- to manage your participation and involvement in the ASD-STAN work if you are an Expert of an ASD-STAN working group, or participant of the ASD-STAN bodies;
- to comply with the legal requirements (10 years for sales invoices);
- to comply with your agreement.

## 4. Q: Does ASD-STAN provide/forward your data to any third party?

**A:** In general, ASD-STAN does not provide, send or forward any of your data to any third party, with three exceptions:

- <u>If you are a customer</u>: data to complete the purchase of a standard at the ASD-STAN webshop. Some data may be provided to the Credit Card company to ensure payment and download the purchased product.
- <u>If you are a customer of the ASD-STE 100 document</u>: your data (Name/Surname, Address, Company, Email address, Position, Website, Country) will be forwarded to the ASD PSSG for purchase/free download of the ASD-STE 100 document.
- <u>If you are ASD-STAN expert and participate in our Working Groups:</u> your data will be provided to CEN to establish the access to CEN electronic Livelink system via ASD-STAN.

#### 5. Q: How long your data will be stored?

**A:** The data will be stored as long as it is necessary for ASD-STAN to manage the activity in which you are involved. To comply with the Belgian legislation your data for any purchase activity done through ASD-STAN will be stored for 10 years. Data linked to a standard development may be stored for archiving purposes until deletion is requested.

The data may be stored as much as it is required to fulfill the legal requirements.

### 6. Q: What are my rights regarding the stored data by ASD-STAN?

**A:** You have the right to:

- be informed about the set of data stored by ASD-STAN, according to the §15 of GDPR;
- rectify any data stored, according to the §16 of GDPR;
- erase any data stored, according to the §17 of GDPR;
- restrict processing data, according to the §18 of GDPR;



- object, according to the §21 of GDPR;
- data portability, according to the §20 of GDPR.

## 7. Q: Do I have the obligation to provide the data requested by ASD-STAN?

**A:** In order to perform the requested tasks (purchase, information distribution, ASD-STAN body/working group participation...) the requested data have to be provided, otherwise ASD-STAN is not able to provide or cannot guarantee the provision of the requested service.

## 8. Q: Is there any automated individual decision-making by ASD-STAN?

**A:** There is no automated individual decision-making by ASD-STAN. Credit Card assessments are not performed by ASD-STAN, but may occur by the relevant Credit Card company.
